President Mire called this Committee of the Whole Meeting to order first addressing is to discuss the implantation of the Operating Budget System and appointment of the Budget Officer. Mire asking the Board for approval of appointing Ben Barber as Budget Officer. Discussion took place about compensation for the added responsibilities. Barber will keep track of the additional time invested in his new responsibilities and report at the end of the fiscal year at which time the Board will pay out accordingly. Rankin motioned to appoint Barber as Budget Officer. Clark seconded. All present voted yes. Motion carries.

Mire then moved to the next item on the agenda, reallocation of funds in the 2018/2019 fiscal year budget. Robertson motioned to approve the 2019/2020 Fiscal Year Operating Budget Ordinance A04-2019. Rankin seconded. All present voted yes. Motion carries. Other budget discussion took place clarifying budgeted items. Mire did note the Water Loop Project may not start until next spring due to permitting through the railroad.

Having no further business to conduct at this time, Schnieder motioned to adjourn this April 25th, 2019 Committee of the Whole Meeting, Fowler seconded. President Mire adjourned by consensus of the Board at 7:118pm.
